To qualify for \$400, open a new Tech CU checking account by 6/30/24, and complete at least 10 qualifying transactions (including payroll deposits, debit card purchases, bill payments, or electronic payments—excluding bank-to-bank transfers) every month for 6 consecutive months. The first qualifying transaction must be completed within the first month after account opening. For example, if your opening date was 2/22/23, you would need to make 10 qualifying transactions between 2/22/23 and 3/21/23, the next 10 qualifying transactions between 3/22/23 and 4/21/23, and so on, until 8/21/23. A \$400 credit will post to the checking account and be available for withdrawal after the last qualifying transaction has been fulfilled. If the checking account is closed less than 6 months after account opening or the required minimum transactions are not completed, the \$400 account credit and any dividends will be forfeited. Must be 18 years or older. Offer valid only for individuals who open new-to-Tech CU checking accounts and have never caused Tech CU a loss of any kind.
