HOUSEHOLDING CONSENT FOR RELATIONSHIP REWARDS PROGRAM

The Relationship Rewards Program rewards members who maintain specified combined account and loan balances with Technology Credit Union. Possible rewards may include fee waivers, higher yields on savings, lower rates on loans, or other benefits the Credit Union determines. Specific available rewards may vary from time to time.

Householding allows for households where two or more Technology Credit Union members reside to combine their balances for purposes of determining eligibility for the Relationship Rewards program. If Technology Credit Union members living at your address agree to household balances, each member who resides in your household will be eligible for the level of Relationship Rewards for which the total account and loan balances at your household qualify you. Example: If a Relationship Rewards Travelers Check purchase fee waiver requires at least \$5,000 in combined deposit, loan, and investment balances, and member A in your household has a \$1,500 end-of-month aggregate balance in April and member B in your household has a \$3,500 end-of-month aggregate balance in April, both member A and Member B will receive the fee waiver for Travelers Checks in May. If the combined aggregate household balances generate a Relationship Fee at a given time, the account designated below as the Master Account will be charged the fee. Example: If a Relationship Fee is to be charged if aggregate balances fall below \$5,000 and if the combined aggregate end-of-month household balances in both member A and member B accounts are less than \$5,000 in January a Relationship Fee will be assessed in January only to the Master Account. The fee will not be charged to the other householded accounts.

All Technology Credit Union members completing this form must reside at the same physical address. Exceptions to this rule are: temporary school address, temporary military address, or temporary job assignment address.

Regardless of householding status, Technology Credit Union will release information only to persons who are owners or authorized signers on accounts or to persons who are obligors on loans. Consent to householding will not change ownership of any accounts or obligations on any loans. If at any time the Master Account holder discontinues his/her membership with Tech CU and the Additional Household Account holders wish to continue participation in the householding program, a new Householding Consent form must be completed and submitted to Tech CU. If a new Householding Consent form is not submitted to Tech CU after the Master Account is closed, all Additional Household Accounts will be considered Master Accounts and any Relationship fees will affect each account.
